- 9.9.18 GPI shall continue to oversee the 3:45-4:45 Speaker Meeting following the IG Meeting. Meeting contributions will be passed to the GPI Treasurer who will add \$5 per month to the donation for the extended hour of use of the facility. PASSED
- 9.9.18 The 12th Step Within or Marathon Chairperson shall have events on Abstinence, Sponsorship, and Working the Steps every year. PASSED
