- **Abusive Texts/Meeting Options:** to list another phone number than a personal number if there is a problem.
- **Definition of Abstinence:** Abstinence is the action of refraining from compulsive eating and compulsive food behaviors while working towards or maintaining a healthy body weight. This corrects the information given last month.
- Suggested Contribution \$5/week: Expenses are rising at every level of OA, and this is now the suggested contribution, adjusted for inflation and increased costs.
- Representatives' Ideas for Attracting New Members:
 - Public Service announcement sent to local TV stations, posters placed, letters to UPMC PCP 's;
 - o Penny Saver/Newspaper ads
 - o Pittsburgh Today TV show/ have someone anonymously give a share behind a screen
 - UPMC has an eating disorders program/place poster at Western Psych Hospital/target other eating disorders programs in the area
 - o Suggestion to take meetings into eating disorders programs in the area
 - Follow up with DC Intergroup re: social media consultant targeting younger people
 - Colleges and universities/social media is a good way to reach younger groups
 - Hospital/clinician education programs
 - One meeting had a high school senior as a regular attendee. Personal 12th step work with younger people can be effective.
 - We can do a great job at getting the word out, but we need to be sure that our meetings have a recovery that folks will want to return to.
 - Be sure to do a follow up phone call with newcomers, and stay after the meeting to answer questions
 - This will be a standing item on the agenda. We do not currently have an outreach chair. Please let Ro know if you are interested in this role.
